Dear Friends,

The early weeks of 2026 have not been easy for our country, or for the world. I struggle at times to know what to say in response to the growing violence, lawlessness, lack of compassion, and abject cruelty on display coming from so many directions. The world as we have known it is in radical upheaval, and folks seem to be living according to different versions of reality, as if truth itself is up for grabs. Do we really believe that truth depends on whom we listen to, and what conveniently fits a preferred narrative?

The swelling of chaos and confounding messaging of leaders who leverage the words, but not the ways, of Christ Jesus, is profoundly disorienting. Honestly, if not for the spiritual practices that ground me—prayer, meditation, walking in the woods, contemplation on Scripture and other writings where I hear the wisdom of God speaking clearly—I wonder how I'd cope much of the time. My spiritual disciplines help me to imagine a response other than despair, help me to see that this world is far more complex and God's activity far more compelling than the media and other dominant messaging suggest.

How about you? Do you have grounding spiritual practices? If not, I want to encourage you to consider taking one up, even just for a season.

Lent, which starts on Feb. 18th this year, is a 40-day (plus Sundays) opportunity to see how a daily practice of carving out even 10 minutes for quiet contemplation can completely reframe things for us. It can re-ground us in what the apostle Paul described as a “more excellent way.” Church tradition (and the Revised Common Lectionary) has supplied us with a series of Bible readings to help guide our imagination to deeper places as we engage the questions that human souls are here to grapple with in meaningful ways.

Lent begins in the ache, the questions, the tension between love and loss. It’s a season that does not rush toward resolution, but invites us to slow down. To notice and reflect. To repent: to turn with honesty, and to journey with Jesus through wilderness, confrontation, and cross. Along the way, we listen to voices from the margins. We learn from stories of resistance and renewal. And, we remember that God meets us not in strength, but in surrender. It’s powerful, perspective - and life-changing stuff!

This is the work of imagination: it allows us to envision a world remade by compassion, forbearance, mercy. It enables us to see that repair and restoration is possible—even in the shadow of overweening imperial forces. Imagination allows us to visualize, and practice, love that outlasts despair or defeat. Lent calls us into this holy labor—not as a solitary act, but as a communal path toward transformation.

I hope you’ll participate in this intentional journey in a new way this year. If you’ve never observed Lent with a daily practice (whether purposefully abstaining from something, or conscientiously taking on a new discipline), then let this be a first for you. And if you have before, then let it be all new to you this year.

This Lent, we will join our church siblings from Brookline and Mason at the Brookline Community Church for our Ash Wednesday service, at 7 p.m. Sunday mornings will keep us focused on “The Work of Imagination” as we imaginatively consider the experience of those who were closest to Jesus in the world-changing first century (everything was being rearranged for them, too!), and allow their journey to inform our own. Join us at Loaves & Lessons on Thursday evenings for simple, nourishing meals along with satisfying spiritual conversations, as we stay tethered to the things that truly matter. (Please also consider signing up to either provide, or help with clean-up after, the simple meals!)

In the coming season, I look forward to observing and imagining together what powerful new work God is calling us to do in this world, and to practicing and experiencing all that Love will do through us!

A Report from the Bylaws Task Force

“Let love be genuine; hate what is evil; hold fast to what is good; love one another with mutual affection; outdo one another in showing honor. Do not lag in zeal; be ardent in spirit; serve the Lord. Rejoice in hope; be patient in affliction; persevere in prayer.”

(Romans 12:9-12)

As many of you know, a small Task Force of very dedicated members has been meeting multiple times a month for nearly three years now in order to update our Church Bylaws. It's tedious work, but so important as our congregation works to articulate our best understanding of how we're called to live and minister together in Christ-centered covenant community. Because, of course, congregations change as surely as culture itself does; integrity of our mutual understanding means we need to periodically assess and adjust the document that lays out our understandings.

Last fall, we had a series of open conversations at which all members were invited to share their thoughts, concerns, and/or affirmations about the work the team had done thus far. And at those meetings, members of the Bylaws Task Force worked very hard to listen, record, and incorporate the majority opinions about a variety of matters. The proposed new Bylaws will be made available this month to consider for adoption at our Annual Meeting on March 1st (please note the date in your calendar and plan to attend!).

Some of the deepest and most extensive discussions pertained to what appropriately demonstrates active membership in our congregation. This is a key question because it determines who possesses the ability to vote on significant matters in our communal life. It is important that we clarify what we appropriately expect from one another in terms of active engagement. We are a group of people who covenant to live in intentional ways with one another so as to deepen our faith and discipleship to Jesus Christ. When conflict arises from time to time (as it inevitably will; we're a bunch of human beings here), painful rifts can deepen and cause damage to the broader community. Trust in the integrity of our community is undermined when folks who've not invested in, or engaged with, the life of the congregation for years are as entitled to decide on matters as folks who've regularly offered time, talent, and treasure in discerning and manifesting God's vision for this community. There can and should certainly be openness to listening to the views of former members, even if they are no longer eligible to vote. Clarifying who constitutes an active member is important so that we can agree who is truly invested in the well being of this community's life in Christ at a given moment.

There is no question that some members will not see their strongly-held opinion reflected in the revised document. This is by no means a way of implying that those expressed opinions didn't matter or weren't heard. To the contrary, every opinion – whether agreeing or dissenting – was carefully (often laboriously!) weighed and considered by the team, alongside the other expressed concerns and points of view. As a Congregational community, the democratic process and consensus is paramount to our covenant life together - and the Bylaws Task Force hopes that this deep consideration is evident.

While it's not exactly scintillating reading, we hope that every member will take the time to read what's being proposed. If there are questions needing clarification, please reach out to a member of the Task Force A.S.A.P. so that the proceedings at the Annual Meeting can move forward as smoothly as possible.

The Church of Jesus Christ has, across the millennia and across cultures, assumed a vast array of shapes, sizes, and ways of being together. The Bible contains some instructions (including those issued by Paul in the citation from Romans above). And yet, as those who believe that God is still speaking, it's up to us to discern and articulate as clearly as possible how God is inviting our specific church community to live and minister together. May we each and all experience the blessing of being intentional about our own engagement in the process!

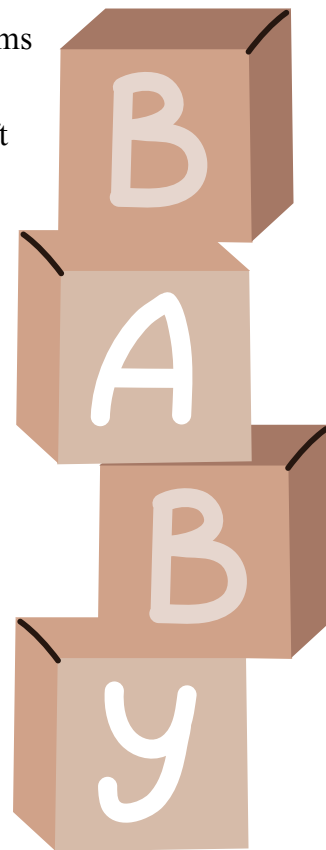

Spring Clothing Drive for the Pass Along Project

This spring, we will be collecting clothing for young people entering the foster care system through the Pass Along Project. This organization currently serves about 600 children each year and hopes to reach all 1,500 children in New Hampshire foster care.

Each child receives a full week's worth of clothing to help them feel comfortable and cared for during a very uncertain time, including:

- a combination of gently used and two new outfits
- socks
- underwear
- other seasonal items

Pass Along Project will accept clothing and shoes in all sizes. They **do not**, however, accept toys, books, baby equipment, etc.

For children entering foster care, choosing their own outfit can be the one small piece of control they still have.

Together, we can restore dignity and show them **THEY MATTER** through the simple, powerful gift of clothing.

(For the March 2026 Annual Meeting)

To the members of the Congregational Church of Hollis, New Hampshire, (United Church of Christ) qualified to vote in Church affairs:

You are hereby notified to meet in said Hollis, New Hampshire, on Sunday, March 1, 2026, (snow date of Sunday, March 8, 2026) at 10:45 a.m. to consider the following articles:

Article 1: To consider the reports of the elected officers, boards, committees, and organizations connected with the Church.

Article 2: To elect all officers, board members, and committee members necessary for the upcoming year.

Article 3: To see if the Church will accept and adopt the budget as recommended by the Trustees and Church Council.

Article 4: To see if the Church will adopt the following changes to Articles V and IX of the bylaws (new text in bold, removed text struck through)

Article 5: To see if the Church will adopt the following changes to Article XI of the bylaws and renumber sub-sections as appropriate (new text in bold)

Article 6: To see if the Church will adopt the following changes to Article VIII of the bylaws (new text in bold, removed text struck through)

Article 7: To consider any other business that may come before the meeting.
